who is a politically prominent person?

A politically prominent person is someone who holds one of the following positions:

- a head of state, head of state, minister or state secretary;

- a member of parliament or member of a similar legislative body;

- a member of the leadership of a national political party;

- a member of a higher court, constitutional court or other high judicial authority that makes judgments against which, in principle, no further appeal can be lodged;

- a member of the audit firm or of the management of a central bank;

- an ambassador, chargé d'affaires or senior army officer;

- a member of a management, regulatory or administrative body of a public company;

- a director, deputy director, member of the board of directors or a person who holds a comparable position at an international organization.

Family members of politically prominent persons are also considered politically prominent persons. These are:

- the spouse or partner;

- children or their spouse or partner;

- parents.

Close employees of politically prominent persons are also regarded as politically prominent persons. These are:

- a person who is the ultimate beneficial owner of the organization, together with a policy

prominent person;

- a person who has a close business relationship with a politically prominent person;

- a person who is the ultimate beneficial owner of an organization established for the

real benefit of a politically prominent person;

In case of changes in the status of politically prominent person, you must inform the Intermediary / Financial advisor, as well the involved notary as soon as possible.
